Work Program 2017-2018

Project main topics

- Analysis of the increasing digital transformation of the postal sector
- How social partners are managing this transformation
- Impacts on jobs and competences, training needs, training programmes and work organisation
- better understanding of the programmes of digital transformation put in place in terms of training and cultural evolution
- Better understanding for digital skills and needs for new jobs
- **Opportunities of the digital economy** in terms of new activities development, in particular in the parcels sector, due to growing **e-commerce segment**
- Capacity building to raise awareness on the Social Dialogue Committee for the postal sector (SDC) activities, in particular, but not exclusively, in Central and Eastern Europe
- Dissemination of SDC rules, organization, opportunities, joint outcomes

- Creation of a Joint Steering Committee to coordinate all the Project's phases and support the "Training" WG and the hosting countries
- Questionnaire dissemination to collect information and best practices
